



TRACKING LEGISLATION ON WATER ISSUES

There are a number of water related legislative bills already introduced or in process to be introduced in 2008. Of particular interest is House Bill 2625. This is an act concerning Intensive Groundwater Use Control Areas (IGUCA); relating to mandatory review and advisory committees relative to the determination and implementation of the IGUCA process. KANSAS WATER CONGRESS HAS WINTER MEETING

The Kansas Water Congress Winter Meeting was held on January 14, 2008 in Topeka, Kansas. There was significant discussion by membership and stakeholders in regards to the IGUCA legislation. Included in the discussion was the Kansas Department of Agriculture and Kansas Division of Water Resources. Updates were also provided in regards to the Water Right Transition Program, the CREP program in the Upper Ark, the Kansas vs. Colorado damage funds project as well as the sedimentation issue in Kansas reservoirs. A number of area and state wide legislators were present and participated in the program. FLOW TESTING HOUR METERED WELLS

If you were scheduled to flow test your hour metered well(s) in 2007 but were unable to get this done or if it has been more than 5 years since your last flow test on your hour metered well(s) and you plan to operate the well(s) in 2008, contact the District office to get this done in 2008. The wells should only be tested after they have run for at least a few days in order to get a representative test. If you have recently installed a flow meter or made changes in your diversion works, please notify the District office.

COMMONLY ASKED QUESTION

Could I lose my water right if I don't exercise my water right every 3 years?

NO. The law has been changed so that abandonment of a water right is now considered only after 5 years of nonuse and then only if there is no sufficient cause for the nonuse. If you are closing in on 5 consecutive years of nonuse without due and sufficient cause and wish to protect your water right consider the WRCP program. Contact our office for details.

The 35h Western Kansas Groundwater Management District No. 1 Annual Meeting will be held in Dighton on Tuesday, March 18, 2008 at the Fairgrounds in the 4-H Building, beginning at 1:30 CST. Chief Engineer David Barfield will be our guest speaker as well as a program on current status of the District.

2008 EQIP QUICK RESPONSE AREAS (QRA) PROGRAM

Because of uncertainty on federal funding the announcement of the 2008 QRA Program was delayed. We recently were notified that the funding would be available for 2008 but there is a sign up deadline at your local NRCS Office of Friday, **February 8, 2008**. This part of the ground and surface water program within EQIP has provided significant funding in this District as incentive to voluntarily set-aside water right(s), within a 2 mile radius of public water supplies, for a period from 4-10 years. Participation in 2006 and 2007 was at high levels with a combined total of 3402 irrigated acres and their appurtenant active water rights temporarily retired. This participation has resulted in significant reductions of water use in the target areas around Public Water Supplies. If you have interest in this program contact your local NRCS Office as soon as possible.

2007 WATER USE REPORTS DUE MARCH 1, 2008

The 2007 Annual Water Use Reports are due **March 1, 2008** to the KDWR. Failure to do so can be subject to penalties and fines. You must file the report even if you did not exercise (pump) your water right during 2007. If your water right is enrolled in a federal or state conservation program you **still** need to file a report. If you have questions on filling out your water use report or justifiable use or nonuse, contact our office.
